### The Position

# **Key Duties**

- 1. Ensure that the vehicle is properly maintained at all times in accordance with the Public Service Transport Regulations.
- 2. Ensure the safety and comfort of all passengers.
- 3. Maintain an updated record of vehicle movements by ensuring that vehicle running sheets are updated and submitted on a daily basis.

- 4. Ensure official engagements, visits and invitations are properly coordinated with the Office of the Minister.
- 5. Ensure vehicle defects are reported and addressed within given timeframe;
- Any other duties as assigned by the Honourable Minister for Health & Medical Services.

#### **Selection Criteria**

#### The Person

In addition to a pass in year 12 or Fiji School Leaving Certificate exam, candidates must also possess a legal valid driving license (full license holder) and a valid Certificate of Defensive Driving Course. The following knowledge, Experience, Skills and Abilities are also required to successfully undertake this role:

- 2. Good knowledge and experience in vehicle maintenance, cleanliness and transport rules & regulations;

- 4. Well versed with LTA Act, Rules and Regulations;
