#### The Position

Clinicians employed in this position will operate as recovery oriented clinicians. They will provide best practice clinical interventions for mental health problems, coordinate services, monitor progress and actively support recovery. This position will function as part of the treatment team, along with all other team members, and be expected to contribute to the day to day functioning of the team as well as provide specialist discipline specific interventions as appropriate.

### **Key Duties**

- Responsible for the day to day clinical decisions related to patient care consistent with policy and appropriate delegations
- Provide clients with professional, approachable, and effective counselling services

- Consult with appropriate senior staff when care or individual/group needs requires expertise beyond own scope of competence
- Educate and empower individuals with the ability to cope with issues interfering with everyday life and impacting on mental health and wellbeing.
- Act as a liaison between the client and their family, relevant professionals and informal services to work towards the goals of the treatment plan.
- Advocate on behalf of client and family within health services and wider community to help make the client's preferences known and secure services needed
- Work as part of a multidisciplinary team of health professionals to coordinate treatment plan.
- Implement legislation, regulations, standards, codes and policies relevant to their role in a way that supports patients and their families and carers. Privacy, dignity and confidentiality are maintained and safety is actively promoted
- Support the principles of recovery-oriented mental health practice in working with consumers, families and carers
- Actively respond to the social, cultural, linguistic, spiritual and gender diversity
  of consumers, families and carers, incorporating those differences in practice
- Provide a high standard of evidence based assessment that meets the needs of consumers and families or carers, and facilitates timely entry to services
- Facilitate access to and plan quality, evidence-based values based health and social care interventions to meet the needs, goals and aspirations of patients and their families and carers
- Assist consumers to exit the service or transfer care, and support active steps towards relapse prevention.
- Recognize that patients and their families and carers are part of a wider community, and that mental health services are one element in a wider service network
